1. Parent and Child have read and understand any rules, terms and conditions as provided by 7MYG and specifically agree to be bound thereby.
2. Parent and Child hereby voluntarily release, forever discharge, and agree to hold harmless and indemnify 7MYG, 7MCOC, its elders, members, employees, youth sponsors, agents or representatives, and all other persons or entities from any and all liability, claims, demands, actions or rights of actions, which are related to, arise out of, or are in any way connected with Child's participation in any activity for any and all injury, illness, disease, or death to Child or damage to Parent's or Child's property. In signing this document, Parent and Child fully recognize that if Child is hurt or property is damaged while Child is engaged in this activity, Parent nor Child will have any right to make a claim or file a lawsuit against 7MYG, 7MCOC, its elders, members, employees, youth sponsors, agents or representatives, except where such injury, illness, disease, or death is caused by the negligent acts or omission of 7MYG, 7MCOC, its elders, members, employees, youth sponsors, agents or representatives.
3. In the event that any activity is conducted in a joint effort with any other congregations, all references in this agreement to 7MYG, 7MCOC, its elders, members, employees, youth sponsors, agents or representatives shall also apply to like individuals or groups of the other participating congregations.
4. In the event that Child requires emergency or other medical treatment while under the care of 7MYG, and, in the event that Parent and/or emergency contacts cannot be immediately contacted, Parent authorizes any 7MYG youth sponsor or 7MCOC employee to consent to any emergency or other medical examination, test, treatment, procedure or care deemed necessary.
5. Parent acknowledges that any special medical conditions, allergies, or any medications currently being taken by Child have been identifies at the bottom of this agreement.
